- Upon confirmation participant is required to provide evidence of workers' compensation insurance as applicable. Upon request of the Orangevale's Summer Palooza either: (1) participant will provide evidence of workers' compensation insurance prior to commencement of term; or, (2) participant is independent and has no paid or volunteer employees. This certification does not alter or affect compliance with the workers' compensation requirements in the Labor Code of the State of California.

**RELEASE AND WAIVER OF LIABILITY AGREEMENT**
