VENDOR DEFINITIONS: *Orangevale's Summer Palooza is exclusive vendor of Alcohol.

Craft Booth: Sales are limited to hand-made, original items. If you did not make it yourself, you are considered commercial. If your items are manufactured or mass produced, you must use a commercial vendor's application. CRAFTS BOOTHS CAN SHARE with Event's prior approval! Booths will be monitored daily.

Commercial Booth: Vendors in this category are defined as retail businesses that operate with or without a storefront that have tangible retail products for purchase on site or off site. If you purchase any product to re-sell, if you provide any professional services and/or consult, you are qualified as a "Commercial Vendor" and must register as such. The committee reserves the right to accept or exclude duplicate businesses based on needs and size. Exclusivity may be extended at the event's discretion. See Sponsorship available for exclusivity or call 916.934.2207.

Non-Profit Booth: MUST provide legible proof of 501C-3 status. (Concessions does not apply to Non-Profit rate)

Concessions Booth: Vendor must submit required paperwork (TFF Info and Menu) with application to be considered for show.

Orangevale Summer Palooza does not guarantee sales.

- The event is a rain or shine event. There are no refunds due to inclement weather.
- Vendor acceptance is subject to vendor application and acceptance by the event organizer or host.
- Deposit or full Payment is due at time of application. Application will not be considered without payment.
- If vendor is not accepted into the event, payment will be refunded.
- Booth space may NOT be assigned, shared or sub-leased to others without prior authorization. Crafters can share with approval.
- Any vendor who does not show up will forfeits the return of any fees. Please be sure you understand the dates, hours and the location of the Orangevale's Summer Palooza in Sacramento County, Northern California.
- Any booth cancellations must be made by May 1, 2023 to receive 50% refund (deposits are non-refundable).NO exceptions! Any application changes must be submitted by May 1, 2023 and approved by the event committee.
- A limited number of vendors in any category will be accepted into the event. Decisions are based on, but not limited to, history, items to be sold, payment and date of paperwork received. Accepted vendors will receive a confirmation packet and notification by email. Each Vendor will receive 1 parking pass for the designated vendor area. General Area parking passes are available at a discounted price \$15 for 3 days (valued \$21) for vehicle and trailer or oversized vehicles \$25 for 3 days (valued \$30).
- The event will assign placement of your booth. We do our best to accommodate special needs but it is not guaranteed and is at the discretion of event management. Craft booths for weekend only will be assign space by Vendor Coordinator.
- Private generators will be allowed with approval. Generators must be silence or noise reduced. Must have fire extinguisher in booth and meet the Sacramento Metro Fire requirements.
- Vendors/Exhibitors/Concessions are expected to stay for the duration of the event unless approved by the event.
- Vendors/Exhibitors/Concessions are expected to leave their area clean and clear of all debris. Cleaning deposit will be refunded 3-5 days after the event.

Annual Privacy Notice - No Action Needed

Your account records are covered by state laws that protect your privacy. The Information Practices Act (Civil Code §1798.17) requires the California Department of Tax and Fee Administration (CDTFA) to notify you each year of your privacy rights.

The CDTFA administers many of the state's tax and fee laws. We ask you for your information (when you apply for your permit, certificate, license or renewal, relief request, payment plan, offer in compromise, settlement, or other applications) that is either required by law, or is used for our registration records. We will use the information to determine whether you are paying the correct amount of taxes and fees, or to collect any amounts you owe. You must provide all information requested, including your social security number (used for identification purposes [see Title 42 U.S. Code section 405(c)(2)(C)(i)]). A complete list of the California Revenue and Taxation Codes authorizing the CDTFA to maintain your information for the administration of its programs is available on our website at www.cdtfa.ca.gov/formspubs/cdtfa324gen.pdf.

What happens if I don't provide the information?

Your application for a permit, certificate, license, relief request, payment plan, or other programs may not be processed if your information is incomplete. If you are not able to file your required returns, you may have to pay penalties and interest. You may owe more taxes or fees, or receive a smaller refund, if you do not provide the requested information to support your exemptions, credits, exclusions, or adjustments.

If you provide fraudulent information, civil penalties may apply and you may be subject to criminal prosecution.

Can anyone else see my information?

Yes; while your records are covered by state laws that protect your privacy, the CDTFA may share information regarding your account with specific local, state, and federal government agencies, or companies contracted and authorized to represent those government agencies.

If authorized by law, we may release the information printed on your permit, certificate, or license, such as your account type, start and closeout dates, and the names of business owners or partners to the public. When you sell a business, we may give the buyer or other involved parties information regarding any of your outstanding tax liabilities.

With your permission, we can release some or all of your account information to your authorized representative.

The CDTFA may disclose information to authorized officials of the following agencies, among others:

United States government agencies, State of California government agencies and officials, state agencies outside of California for tax enforcement purposes, State of California Cities, Counties and Districts, State of California City and County attorneys, prosecutors and law enforcement departments, and agencies authorized to enforce local tobacco control ordinances.
